This has reference to your proposal dated 30th October, 2013 and subsequent letter No.PCT/112/2014 dated 7th July, 2014 requesting for grant of affiliation to start new Engineering College in the name of A.P. Shah Institute of Technology proposed to be started at Survey No.12, Opp. Hypercity Mall, Kasarvadavali, Ghodbundar Road, Thane (West) - 400615 for starting (1) Mechanical Engineering (60) (2) Civil Engineering (60) (3) Electronics & Telecommunication Engineering (60) (4) Information Technology (60) and (5) Computer Engineering (60) degree courses from the academic year 2014-15.

In this connection, I am directed to inform you that considering the permission granted by the above mentioned authorities to your Trust, I am pleased to inform you that your society has been granted permission for the first time affiliation to start new college of Engineering from the academic year 2014-15 imparting branches of (1) Mechanical Engineering (60) (2) Civil Engineering (60) (3) Electronics & Telecommunication Engineering (60) (4) Information Technology (60) and (5) Computer Engineering (60) in the name of A.P. Shah Institute of Technology proposed to be started at Survey No.12, Opp. Hypercity Mall, Kasarvadavali, Ghodbundar Road, Thane (West) - 400615 subject to satisfactory report of the Local Inquiry Committee and submission of fixed Deposit in the Office of the Directorate of Technical Education.

Further, the college has to fulfill the conditions mentioned in the above referred G.R., A.I.C.T.E. letter and D.T.E. letter and also to fulfill the following affiliation conditions:

- (1) That the conditions laid down by the University from time to time
- (2) That the minimum attendance of all the students must not be less than 75% during the academic year and college will have to complete the syllabus of all the subjects during the academic year.
- (3) Admissions should not be linked with donation.
- (4) That the college will strictly follow the Ordinance 2802 in respect of preventing the colleges and Management of colleges from accepting donation or capitation fee for admission of students in the colleges, quoted in the University Circular No.Aff./Recog./49 of 1987, dated 4th February, 1987 (copy enclosed).
- (5) That college should follow the norms as prescribed and circulated by the University vide Circular No.CONCOL/75 of 1988 dated 3rd March, 1988 (copy enclosed).
- (6) That college should not admit the students over and above sanctioned intake.
- (7) The college shall appoint the teaching as well as non-teaching faculty as per the University and U.G.C. norms and also provide infrastructure facilities for the purpose.
