And

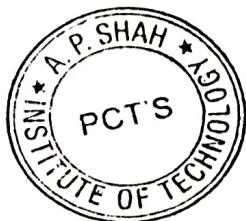
**Hospital** having its registered office at Kasarvadli, Ghodbunder Road, Thane hereinafter referred to as '**TIETEN MEDICITY**' (A Venture of Sparkk Life Sciences)

### WHEREAS

The Company intends to provide medical services and facilities to their staff and students such as Emergency, Hospitalization (IPD), OPD treatments etc. from a super specialty facility, **TIETEN MEDICITY**. The Institute has approached the Hospital for providing the medical services and hospitalization facilities on the terms and conditions agreed hereunder.

**NOW THIS MEMORANDUM WITNESSETH** and it is agreed by and between the parties as follows from : **01/04/2024 to 31/03/2026**.

1. Students/Staff shall present their individual Institute Identity Card issued by The Institute and an Authorization letter duly signed by the authorized signatory of The Institute at the time of admission/medical treatments in 'The Hospital'.
2. Hospital will provide Ambulance services to Institute in emergency (Rs-750) will be charge for non cardiac ambulance.
- 2.(a) Hospital will provide First Aid treatment at TIETEN MEDICITY Casualty to A.P Shah Institute of Technology's students or staff during their office hours.
- (b) After office hours if any staff/student get admitted then hospital will ask for security deposit and bill will be recovered from that individual only.
3. All the expenses incurred by the Hospital for patient treatment will have to bear by A.P Shah Institute of Technology/ Staff/ student during the office hours.

4. Bills should be prepared on the day of discharge of the patient and same should be certified by the concerned student/employee. The Certified bills along with a copy of original discharge card should be sent to 'A.P Shah Institute of Technology/staff/ student for settlement and payment.
5. All Medical Bills shall be settled within 10 days from the date of its submission.
6. Service tax will be applicable on the prevailing rates & tariff of the hospital as per govt. rule.
7. Institute will allow the hospital for organizing Health Awareness programme like Health Checkup camp, Health Awareness Talk, Health Tips standy and other promotional activities.
8. OPD Consultation charges will be Rs.700/- to Rs. 1500/- for any doctors. Follow up charges will be Rs- 600 to 1000/- for any doctors .This would be valid up to -7 day from the date of the first visit.
9. Special discounted 20% will be given to A.P Shah Institute of Technology's students and staff on OPD.
10. MOU shall be valid for a period of 2 year from the date of signing this MOU.

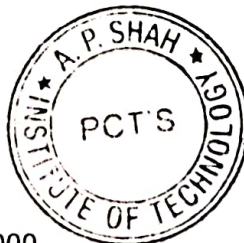
